#### **GENERAL**

The LAKES OF SAVANNAH SOUTH COMMUNITY ASSOCIATION, INC., is a Texas non-profit corporation located in Brazoria County, Texas. The subdivision is established by a Declaration filed of record in the Official Public Records of Real Property in Brazoria County, Texas. These rules are made and adopted pursuant to the authority granted by the Declarations, the By-Laws, and pursuant to the authority granted to the Board of Directors in Article III of the Declaration.

The following Policy is effective June 1, 2015, and is applicable to all Owner(s).

#### GARAGE SALE POLICY

This Garage Sale Policy was approved by the Board of Directors for LAKES OF SAVANNAH SOUTH COMMUNITY ASSOCIATION, INC., on the 27 day of May 2015.

Purpose: The intent of the policy is to clearly convey the restriction preventing garage sales, estate sales, yard sales or any other independent action of the kind.

Definition: Garage, Estate, or Yard sale: The sale of personal property in, at or upon the premises that is residentially zoned or residentially occupied. This includes, without limitation, sales of personal property from the garage, driveway, yard, patio, or house areas of such premises. No garage/moving/rummage/estate sale of similar activity may be conducted on a Lot more than three (3) times each calendar year. Each sale shall only be conducted one (1) time in the Spring, one (1) time in the Summer, and one (1) time in the Fall. The Homeowners Association will schedule the day of the garage sale each season. No sale may commence earlier than 7:30 a.m., extend past 5:30 p.m. or continue more than one (1) day. Garage sale signs are allowed on the day of the sale only.

Adopted by unanimous vote of the Board of Directors of the LAKES OF SAVANNAH SOUTH COMMUNITY ASSOCIATION, INC., at a meeting held on May 27 2015.
